APPROVAL OF THE DRAFT RED HERRING PROSPECTUS

The Chairman informed the board of directors ("**Board**") of AASTHA SPINTEX LIMITED the ("**Company**") that pursuant to the resolutions passed by the Board of the Company at its meeting held on July 16th, 2025 and the Shareholders Approval dated August 08, 2025 vide EGM, the Company was authorized to undertake an initial public offer of its equity shares bearing face value of ₹ 10/- each (the "**Equity Shares**") comprising a fresh issue of Equity Shares by the Company ("**Fresh Issue**") (the "**Issue**"). The Chairman tabled before the Board the draft red herring prospectus of the Company in relation to the Issue, for its approval. The Board perused the matter and noted that the draft red herring prospectus shared with the Board has been reviewed by it and after being satisfied that all the information included in the draft red herring prospectus is true and correct, the following resolution was moved and passed unanimously:

"RESOLVED THAT, on recommendation of IPO Committee and in furtherance of the resolution passed by the board of directors of the Company (the "**Board**") on July 16th, 2025, the Shareholders Approval dated August 08, 2025 vide EGM and subject to applicable laws, the draft red herring prospectus (the "**DRHP**"), in respect of the initial public offering of equity shares of face value of ₹ 10/- each of the Company (the "**Equity Shares**") consisting of fresh issue of 16,000 Lakh (the "**Issue**"), at such price as may be determined in accordance with the book building process prescribed under the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended, and as agreed to by the Company in consultation with the book running lead managers to the Issue (the "**BRLMs**"), as provided to, and tabled before the Board, containing the requisite information as prescribed by applicable laws and regulations, be and is hereby approved for filing with Securities and Exchange Board of India ("**SEBI**"), BSE Limited and National Stock Exchange of India Limited (which together with BSE Limited shall collectively be referred to as the "**Stock Exchanges**") and/or such other authorities or persons as may be required.

RESOLVED FURTHER THAT the DRHP is hereby recommended for signing by each of the Directors of the Company, the Chief Financial Officer of the Company (or their duly authorized representative and each such person be and is hereby authorized to sign the declaration page of the DRHP for and on behalf of the Company and file the same with the SEBI for their observations and with the Stock Exchanges for listing purposes."

RESOLVED FURTHER THAT Mr. Divyang Jashwant Patel, Managing Director and Mr. Vivek Rasiklal Gothi, Whole-time Director be and are hereby severally authorised to make corrections or modifications, if any, and to finalise the DRHP for purposes of filing with SEBI, the Stock Exchanges and such other authorities or persons as may be required, issue such certificates and confirmations as may be required and do all acts, deeds, matters and things and undertake such other necessary steps to implement the above resolution, including without limitation, to settle any questions, difficulties or doubts that may arise in relation thereto."

RESOLVED FURTHER THAT, the IPO Committee, as constituted on August 08th, 2025 is hereby authorized to undertake, approve and adopt any subsequent changes, correction, updates, alterations, revisions, modifications or amendments in the DRHP in accordance with the applicable law and regulations prior to filing with the SEBI including to determining the number of shares and/or the amount proposed to be raised."
